3. Treasurers report

• \$13,711.03 in equity, no liability, will be at about 11k after paying for meeting – about same total as two years ago

4. Technology

- We are now using GoToMeeting for both board meetings and webinars.
 Questions about GoToMeeting: Can members use GoToMeeting for other meetings? Do they charge extra for each meeting?
- Can we open up webinars & charge outsiders? A goal A series of webinars for which parishes could sign up for. It would be nice to do polls during webinars and evaluations afterwards.



- We have a goal of 6 webinars per year Sept Ken Griesmer, Oct Pam Hardiman, Nov, Jan, Feb, Mar – Karen Schmidt. We should alternate artist/liturgical consultant presentations.
- It would be nice to record these so that people can access them later. Not
 everyone can attend at the time the webinar is given. Robert Habiger is
 retiring in March.
- When you do a webinar, Robert needs a low resolution picture of yourself, title, and a short description of your talk. You can do a PowerPoint and show video. The presenter needs headset and microphone, at least a microphone. Sound quality is much better.
- We should check out the GoToMeeting plans, as it costs us each time it is used, plus a monthly fee. Are we overpaying? Maybe we could use a webinar on how to do a webinar and how to be a participant. Or maybe just written instructions on the website.
- Feedback would be nice. Perhaps use SurveyMonkey after webinar. Should we keep doing webinars? Why? How does it expand in the future?
- Another way to use GoToMeeting Conversations with an agenda and a coordinator, but no presenter. We'd like to use it more often.

5. Membership report

- Seem to be contracting, down 15-20%, 38 (and a few more coming) members. We seem to be about 1/3 consultants, 1/3 architects, and 1/3 artists. We may need a membership coordinator.
- Getting people to renew is difficult; people don't respond to email. In the past board members call & recall.
- One approach is to get members more involved. Perhaps we have a webinar with interviews of members and panel discussion. Artists can meet consultants & vice versa. Quick Pecha Kucha-type format.

6. Relevance

- How do we stay relevant?
- Education not asked for so often. Bishops often don't want liturgical consultants, others require them.
- Focus on design and unique things we can offer.
- Why did we each come? Answers Education, networking, topic of cultural diversity, hope to see photographs on website, what is the vision, , listen to others, camaraderie, support organization.
- The good news seems to be that more artists are being commissioned.

- James Heck San Antonio, TX, architect, religious architecture, 130 projects in history, handles most religious architecture in firm, San Antonio, historic preservation, good architecture makes a difference and helps people

- What does "members present" mean for an online meeting? Answer:
 Members signed in at GoToMeeting
- Remove first sentence of 4.3
- 5.3 Change "team member" to board members, treasurer spelling, "may be ex-officio" change to "are ex-officio"
- 5.4 remove paragraph
- 5.2 "of the 3 Board Members" should be "of the Board Members", strike "atlarge"
- Three board members shall be elected in odd numbered years president and two at-large. The board may appoint one carry-over for a one term period. There will be a 2 year term for each of the board members; members may rotateappointed on numbered years
- 10.3, 10.5 remove vice president
- Consistent language Board Members, not board of directors
