#### **DISCUSSION:**

- 1. Meeting Minutes
  - Approve minutes of April 16<sup>th</sup> 2015 meeting
  - Carol has accepted Pam Hardiman's resignation as Secretary. If you have any suggestions for a new person for this Board position, please let the Carol know. Some suggestions have been Cindy or Bob Kessler and Paul Barribeau.
- 2. Treasurer's Report
  - Robert Habiger was not able to attend, no report submitted.
- 3. Membership Report
  - There have been 46 members to renew so far.
  - Not everyone who said they were going to renew has renewed. Juanita will contact those who have not renewed to remind them. Some of these members are Michael Hutchinson, George Hoelzeman and Shelley Kolman Smith.
  - Juanita would like each Board Member to submit at least five names of potential new members that she might contact. This effort could be coordinated with the virtual "Grand Opening" of the website at the beginning of September.
- 4. Website
  - The webinar for members on how to use the website has been postponed until Tuesday May 19<sup>th</sup> at 3:30pm EDT.



- The old website was removed and the new website was put up on the web Monday May 11<sup>th</sup>.
- A few glitches have been found in the workings of the new website. Some of these are:
  - In the Member's Portfolio Section, image no. 1 does not insert properly.
  - When someone uses the hotlink for a members Email address the subsequent Email message has the Email address in quotes and therefore not usable.
- Board Members should explore and use the site before the webinar so as to report any potential glitches or errors.
- A virtual "Grand Opening" was proposed. This virtual "Grand Opening" would occur at the beginning of September and involve the following:
  - Building an Email list of members of IFRAA, members of FDLC, diocesan offices of facilities and worship, other denominational level offices of facilities and worship, etc.
  - Place notices or announcements of website virtual "Grand Opening" on websites and in newsletters of partner organizations.
- Additional planning for the virtual "Grand Opening" of the website at the July Board meeting.
- 5. Elections and Constitution
  - The vote on Board Members and approval of Constitution will be done using Survey Monkey.

    - Issues & Case Studies (panel of artists, architects & liturgical design consultants)
    - Workshop for staff of Diocesan Offices of Worship
